INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

We have performed the procedures enumerated below, with which those charged with governance and the management of the Logan County Family and Children First Council (the FCFC) agreed, solely to assist those charged with governance in evaluating receipts, disbursements and balances recorded in their cash-basis accounting records for the years ended June 30, 2012 and 2011, and certain compliance requirements related to these transactions and balances. Management is responsible for recording transactions; and management and those charged with governance are responsible for complying with the compliance requirements. This agreed-upon procedures engagement was conducted in accordance with the American Institute of Certified Public Accountants' attestation standards and applicable attestation engagement standards included in the Comptroller General of the United States' *Government Auditing Standards*. The sufficiency of the procedures is solely the responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

This report only describes exceptions exceeding \$10.

Cash

1. The Logan County ESC and the Logan County Auditor were the custodians for the FCFC's deposits. We compared the FCFC's fund balances reported on its June 30, 2012 financial statements to the balances reported in the Logan County ESC's and the Logan County Auditor's accounting records.

2012

The children's trust fund balance as of June 30, 2012 should have been \$5,647 instead of the reported amount of \$6,947.

2011

The children's trust fund balance as of June 30, 2011 should have been \$6,800 instead of the reported amount of \$8,100.

2. We agreed the July 1, 2010 beginning fund balances recorded in the financial statements to the June 30, 2010 balances in the prior year AUP working papers. We found no exceptions.

Intergovernmental and Other Confirmable Cash Receipts

1. We selected five receipts from the State Distribution Transaction Lists (DTL) from 2012 and five from 2011. We also selected five receipts from the County Auditor's Vendor Expense Reports from 2012 and five from 2011.
 - a. We compared the amount from the above reports to the amount recorded in the corresponding revenue ledgers (REVLED). The amounts agreed.
 - b. We determined whether these receipts were allocated to the proper funds. We found no exceptions.
 - c. We determined whether the receipts were recorded in the proper year. We found no exceptions.

Payroll Cash Disbursements

1. We haphazardly selected one payroll check for each of the four (there were only four total employees) employees from 2012 and one payroll check for five employees from 2011 from the Employee Detail Adjustment Report and:
 - a. We compared the hours and pay rate, or salary recorded in the earnings register report (ERNREG) to supporting documentation (timecard, legislatively approved rate or salary). We found no exceptions.
 - b. We determined whether the fund and account code(s) to which the check was posted were reasonable based on the employees' duties as documented in the employee personnel files. We also determined whether the payment was posted to the proper year. We found no exceptions.
2. We scanned the last remittance of tax and retirement withholdings for the year ended June 30, 2012 to determine whether remittances were timely charged by the fiscal agent (Logan County ESC), and if the amounts charged agreed to the amounts withheld, plus the employer's share where applicable, during the final withholding, period of 2012. We noted the following:

Non-Payroll Cash Disbursements

1. We haphazardly selected ten disbursements from the check register report (CHKREG) for the fiscal year ended June 30, 2012 and ten from the fiscal year ended 2011 and determined whether:
 - a. The disbursements were for a proper public purpose. We found no exceptions.
 - b. The check number, date, payee name and amount recorded on the returned, canceled check agreed to the check number, date, payee name and amount recorded in the Payment Register Detail Report and to the names and amounts on the supporting invoices. We found no exceptions.
 - c. The payment was posted to a fund consistent with the restricted purpose for which the fund's cash can be used. We found no exceptions.

Compliance – Budgetary

We compared the total annual budget required by Ohio Rev. Code Section 121.37(B)(5)(a), to the amounts recorded in the Appropriation Status Report and Revenue Status Report for 2012 and 2011 for the following funds: General and Help Me Grow. The amounts on the annual budget agreed to the amounts recorded in the Appropriation Status and Revenue Status reports.

We did not receive a response from Officials to the exceptions reported above.

We were not engaged to, and did not conduct an examination, the objective of which would be the expression of an opinion on the FCFC's receipts, disbursements, balances and compliance with certain laws and regulations. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
