- The census data provided to the School Employees Retirement System of Ohio as of June 30, 2015 included all enrolled employees.
- Census data changes occurring during the year ended June 30, 2015 to an enrolled employee's eligible compensation, were properly updated with School Employees Retirement System of Ohio.
- All employees required to be enrolled in the School Employees Retirement System of Ohio were properly enrolled.
- The total pensionable wages and employee contributions information reported to the School Employees Retirement System of Ohio agrees with the payroll records of the employer.
