INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

We have audited, in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States, the basic financial statements of Athens County, Ohio, for the year ended December 31, 2015, and have separately issued our unmodified report thereon dated July 25, 2016. These statements do not present a landfill fund, the post-closure liability is included in the General fund and the County's governmental activities.

Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.
