INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Holmes County Park District Holmes County 1 Trail Drive, Suite A Millersburg, Ohio 44654

We have performed the procedures enumerated below, with which the Board of Trustees and the management of Holmes County Park District, Holmes County, Ohio, (the District) and the Auditor of State agreed, solely to assist the Board in evaluating receipts, disbursements and balances recorded in their cash-basis accounting records for the years ended December 31, 2015 and 2014, and certain compliance requirements related to these transactions and balances. Management is responsible for recording transactions; and management and the Board are responsible for complying with the compliance requirements. This agreed-upon procedures engagement was conducted in accordance with the American Institute of Certified Public Accountants' attestation standards and applicable attestation engagement standards included in the Comptroller General of the United States' *Government Auditing Standards*. The sufficiency of the procedures is solely the responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

This report only describes exceptions exceeding \$10.

Cash

- 1. Holmes County is custodian for the District's deposits. We confirmed the District's fund balances reported on its December 31, 2015 and 2014 Holmes County Park District Financial Report to the balances reported in the Holmes County Auditor's accounting records. The December 31, 2015 amounts agreed. The December 31, 2014 did not agree. The 2014 Holmes County Auditors accounting records reported fund balances higher than the 2014 Holmes County Park District Financial Report in the General and Capital Projects funds in the amounts of \$1,498 and \$32,903, respectively.
- 2. We agreed the January 1, 2014 beginning fund balances recorded in the Monthly Financial Report maintained by Holmes County to the December 31, 2013 balances in the prior year audited statements. We found no exceptions. We also agreed the January 1, 2015 beginning fund balances recorded in the Monthly Financial Report to the December 31, 2014 balances in the Monthly Financial Report. We found no exceptions.

Property Taxes, Intergovernmental and Other Confirmable Cash Receipts

- 1. We selected a property tax receipt from one *Statement of Semiannual Apportionment of Taxes* (the Statement) for 2015 and one from 2014:
 - a. We traced the gross receipts from the *Statement* to the amount recorded in the Transaction History Report Revenue. The amounts agreed.

- b. We determined whether the receipt was allocated to the proper fund(s) as required by Ohio Rev. Code Sections 5705.05-.06 and 5705.10. We found no exceptions.
- c. We determined whether the receipt was recorded in the proper year. The receipt was recorded in the proper year.
- 2. We scanned the Transaction History Report Revenues to determine whether it included two real estate tax receipts for 2015 and 2014. We noted the Transaction History Report Revenue included the proper number of tax receipts for each year.
- 3. We confirmed the amounts paid from the Ohio Public Works Commission and Ohio Department of Transportation during 2015. We noted the District is not recording on behalf payments.
 - a. We determined whether these receipts were allocated to the proper fund. We found the District did not record these receipts.
 - b. We determined whether the receipts were recorded in the proper year. We found the District did not record the receipts in 2015.
- 4. The District received \$250,000 from a donor, as described in the Assignment and Assumption agreement dated November 14, 2014. We agreed this amount to the Transaction History Report Revenue. We noted the donor restricted the donation to the pool project. The District spent this amount on various pool project items during 2015.

Over-The-Counter Cash Receipts

The District did not have over-the-counter receipts in excess of 10% of all funds receipts in 2015. We selected 5 (the district only had 5) over-the-counter cash receipts from the year ended 2014 recorded in the duplicate cash receipts book and determined whether the:

- a. Receipt amount agreed to the amount recorded in the Transaction History Report Revenue. The amounts agreed.
- b. Receipt was posted to the proper fund, and was recorded in the proper year. We found no exceptions.

Debt

- 1. The prior audit documentation disclosed no debt outstanding as of December 31, 2013.
- 2. We inquired of management, and scanned the Transaction History Report Revenue and the Transaction History Report Expenses for evidence of debt issued during 2015 or 2014 or debt payment activity during 2015 or 2014. We noted no new debt issuances, nor any debt payment activity during 2015 or 2014.

Payroll Cash Disbursements

- 1. We haphazardly selected one payroll check for three employees from 2015 (District only had three employees) and one payroll check for five employees from 2014 from the Holmes County Payroll Distribution Report and:
 - a. We compared the hours and pay rate, or salary recorded in the Holmes County Payroll Distribution Report to supporting documentation (timecard, or legislatively approved rate or salary). We found no exceptions.
 - b. We recomputed gross and net pay and agreed it to the amount recorded in the payroll register. We found no exceptions.

- c. We determined whether the fund and account code(s) to which the check was posted were reasonable based on the employees' duties as documented in the employees' personnel files. We also determined whether the payment was posted to the proper year. We found no exceptions.
- 2. For any new employees selected in step 1 we determined whether the following information in the employees' personnel files was consistent with the information used to compute gross and net pay related to this check:
 - a. Name
 - b. Authorized salary or pay rate
 - c. Department(s) and fund(s) to which the check should be charged
 - d. Retirement system participation and payroll withholding
 - e. Federal, State & Local income tax withholding authorization and withholding
 - f. Any other deduction authorizations (deferred compensation, etc.)

We found no exceptions related to steps a. - f. above

3. We scanned the last remittance of tax and retirement withholdings for the year ended December 31, 2015 to determine whether remittances were timely paid, and if the amounts paid agreed to the amounts withheld, plus the employer's share where applicable, during the final withholding period of 2015. We noted the following:

Non-Payroll Cash Disbursements

- 1. We haphazardly selected ten disbursements from the Transaction History Report Expenses for the year ended December 31, 2015 and ten from the year ended 2014 and determined whether:
 - a. The disbursements were for a proper public purpose. We found no exceptions.
 - b. The check number, date, payee name and amount recorded on the returned, canceled check agreed to the check number, date, payee name and amount recorded in the Transaction History Report Expenses and to the names and amounts on the supporting invoices. We found no exceptions.
 - c. The payment was posted to a fund consistent with the restricted purpose for which the fund's cash can be used. We found no exceptions.
 - d. The fiscal officer certified disbursements requiring certification or issued a *Then and Now Certificate*, as required by Ohio Rev. Code Section 5705.41(D). We found no exceptions.

Compliance - Budgetary

- 1. We compared the total estimated receipts from the *Amended Certificate of Estimated Resources*, required by Ohio Rev. Code Section 5705.36(A)(1), to the amounts recorded in the Receipt Report for the S09 Park District and N27 Park Land & Building funds for the years ended December 31, 2015 and 2014. The amounts agreed.
- 2. We scanned the appropriation measures adopted for 2015 and 2014 to determine whether, for the S09 Park District and N27 Park Land & Building funds, the Trustees appropriated separately for "each office, department, and division, and within each, the amount appropriated for personal services," as is required by Ohio Rev. Code Section 5705.38(C). We found no exceptions.
- 3. We compared total appropriations required by Ohio Rev. Code Sections 5705.38 and 5705.40, to the amounts recorded in the Budget Report for 2015 and 2014 for the following funds: S09 Park District and N27 Park Land & Building Fund. The amounts on the appropriation resolutions agreed to the amounts recorded in the Budget Report.
- 4. Ohio Rev. Code Sections 5705.36(A)(5) and 5705.39 prohibits appropriations from exceeding the certified resources. We compared total appropriations to total certified resources for the S09 Park District and N27 Park Land & Building funds for the years ended December 31, 2015 and 2014. We noted no funds for which appropriations exceeded certified resources.
- 5. Ohio Rev. Code Section 5705.41(B) prohibits expenditures (disbursements plus certified commitments) from exceeding appropriations. We compared total expenditures to total appropriations for the years ended December 31, 2015 and 2014 for the S09 Park District and N27 Park Land & Building funds, as recorded in the Budget Report. We noted no funds for which expenditures exceeded appropriations.
- 6. We scanned the 2015 and 2014 Receipt Report and Budget Report for evidence of interfund transfers which Ohio Rev. Code Sections 5705.14 .16 restrict. We found no evidence of transfers these Sections prohibit, or for which Section 5705.16 would require approval by the Tax Commissioner and Court of Common Pleas.
- 7. We inquired of management and scanned the Budget Report to determine whether the District elected to establish reserve accounts permitted by Ohio Rev. Code Section 5705.13. We noted the District did not establish these reserves.
- 8. We scanned the Cash Summary by Fund Report for the years ended December 31, 2015 and 2014 for negative cash fund balance. Ohio Rev. Code Section 5705.10 (l) provides that money paid into a fund must be used for the purposes for which such fund is established. As a result, a negative fund cash balance indicates that money from one fund was used to cover the expenses of another. We noted no funds having a negative cash fund balance.

Other Compliance

1. Ohio Rev. Code Section 117.38 requires entities to file their financial information in the HINKLE system formerly known as the Annual Financial Data Reporting System (AFDRS) within 60 days after the close of the fiscal year. We reviewed AFDRS to verify the Entity filed their financial information within the allotted timeframe for the years ended December 31, 2015 and 2014. No exceptions noted.

We were not engaged to, and did not conduct an examination, the objective of which would be the expression of an opinion on the District's receipts, disbursements, balances and compliance with certain laws and regulations. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the information and use of management, those charged with governance the Auditor of State, and others within the District, and is not intended to be, and should not be used by anyone other than these specified parties.
