Because our procedures were not designed to opine on the Corporation's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Corporation's financial statements, transactions or balances for the years ended March 17, 2016 and December 31, 2015.

The Corporation's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found no significant compliance or accounting issues to report.

Current Status of Matters we reported in our Prior Engagement

 The Corporation was unable to provide its Articles of Incorporation for inspection. Upon review of the Ohio Secretary of State's website, it was determined the Corporation's Articles of Incorporation were canceled in 1998. The Corporation has been inactive for several years, only receiving very little interest income. We recommended for the Corporation to establish a new Articles of Incorporation and update its status with the Ohio Secretary of State. The Corporation decided it would be more feasible to dissolve due to having no activity for the last several years. The Corporation dissolved effective March 17, 2016.
