INDEPENDENT ACCOUNTANT'S REPORT

We have examined the Village of Gates Mills, Cuyahoga County, Ohio, management's assertion that the census data and pensionable wages reported to the Ohio Police and Fire Retirement System as of December 31, 2016, and for the year then ended was accurate and complete.

Management asserts that:

- The census data provided to the Ohio Police and Fire Retirement System as of December 31, 2016 is accurate and complete. Census data includes
 - First and Last Name;
 - Last four digits of the social security number;
 - o Contributions remitted to the plan;
 - Pensionable Compensation;
- The census data provided to the Ohio Police and Fire Retirement System as of December 31, 2016 included all enrolled employees.
- Census data changes occurring during the year ended December 31, 2016 to an enrolled employee's eligible compensation, were properly updated with the Ohio Police and Fire Retirement System.
- All employees required to be enrolled in the Ohio Police and Fire Retirement System in accordance with statutory requirements were properly enrolled.
- The total pensionable wages and employee contributions information reported to the Ohio Police and Fire Retirement System for the year ended December 31, 2016 agrees with the payroll records of the employer.

Village of Gates Mills' management is responsible for the assertions. Our responsibility is to opine on management's assertions based on our examination.
