## Independent Accountants' Report on Applying Agreed-Upon Procedures

We have performed the procedures enumerated below, which were agreed to by the Ohio Department of Medicaid (ODM), on Dr. Roland E. Benton's (hereafter referred to as the Provider) compliance with the requirements of the Medicaid Provider Incentive Program (MPIP) for the year ended December 31, 2016. The Provider is responsible for compliance with the MPIP requirements. The sufficiency of these procedures is solely the responsibility of ODM. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

1. We obtained the Provider's encounters during the patient volume attestation period. We scanned the list and found no duplicate encounters. We also scanned the list and confirmed it included multiple payer sources.
2. We recalculated the Medicaid patient volume from the encounters identified in procedure 4 and confirmed the Provider met the 30 percent patient volume requirement.
3. We found that the location where the Provider worked was using a newer version of the electronic health record (EHR) software reported in the MPIP system. We found that the newer version of the EHR software was approved by the Office of the National Coordinator of Health IT.
4. We obtained the Provider's locations and matched those to the meaningful use summary report. We found the meaningful use summary report included one location and the Provider's location list had two locations. We could not determine if detailed meaningful use reports included encounters from both locations on the Provider's list as we received no meaningful use reports with unique patient data, see procedure 5.
5. We obtained supporting documentation for the 10 objectives and compared it to the applicable criteria. We found no exceptions.

We could not perform a scan of the detailed data for those objectives that require only unique patients be counted, and remove any duplicates, as the Provider could not provide unique patient data for each applicable objectives.

6. We obtained supporting documentation for the clinical quality measures and compared it to the applicable criteria. We confirmed the minimum number of measures was met with at least one measure from three different domains.
