## INDEPENDENT ACCOUNTANT'S REPORT

We have examined the Jefferson Township, Madison County management's assertion that the census data and pensionable wages reported to the Ohio Police and Fire Pension Fund as of December 31, 2022, and for the year then ended was accurate and complete.

Management asserts that:

- The census data provided to the Ohio Police and Fire Pension Fund as of December 31, 2022 is accurate and complete. Census data includes:
  - First and Last Name;
  - Last four digits of the social security number;
  - Contributions remitted to the plan;
  - Pensionable Compensation.
- The census data provided to the Ohio Police and Fire Pension Fund as of December 31, 2022 included all enrolled employees.
- Census data changes occurring during the year ended December 31, 2022 to an enrolled employee's eligible compensation, were properly updated with the Ohio Police and Fire Pension Fund.
- All employees required to be enrolled in the Ohio Police and Fire Pension Fund in accordance with statutory requirements were properly enrolled.
- The total pensionable wages and employee contributions information reported to the Ohio Police and Fire Pension Fund for the year ended December 31, 2022 agrees with the payroll records of the employer.

Jefferson Township's management is responsible for the assertions. Our responsibility is to opine on management's assertions based on our examination.

Our examination was conducted in accordance with attestation standards established by the AICPA and the standards applicable to attestation engagements contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether management's assertions are fairly stated, in all material respects. An examination involves performing procedures to obtain evidence about management's assertion.
