## INDEPENDENT ACCOUNTANT'S REPORT

We have examined the Village Preparatory School Willard, Cuyahoga County, Ohio management's assertion that the census data and pensionable wages reported to the School Employee Retirement Systems of June 30, 2025, and for the year then ended was accurate and complete.

Management asserts that:

- The census data provided to the School Employee Retirement System of June 30, 2025 is accurate and complete. Census data includes
  - First and Last Name;
  - Last four digits of the social security number;
  - Gender;
  - Date of Birth;
  - Contributions remitted to the plan;
  - Pensionable Compensation;
- The census data provided to the School Employee Retirement System of June 30, 2025 included all enrolled employees.
- Census data changes occurring during the year ended June 30, 2025 to an enrolled employee's eligible compensation, were properly updated with the School Employee Retirement System.
- All employees required to be enrolled in the School Employee Retirement System accordance with statutory requirements were properly enrolled.
- The total pensionable wages and employee contributions information reported to the School Employee Retirement System for the year ended June 30, 2025 agrees with the payroll records of the employer.

Village Preparatory School Willard's management is responsible for the assertions. Our responsibility is to opine on management's assertions based on our examination.

In our opinion, management's assertions related to the accuracy and completeness of the census data and pensionable wages as described above provided to School Employee Retirement System as of and for the year ended June 30, 2025 are fairly stated in all material respects.

This report is intended solely for the information and use of Village Preparatory School Willard's management, those charged with governance, and School Employee Retirement System management, and plan auditors to provide assurances that the census data reported to the School Employee Retirement System is accurate and complete.
