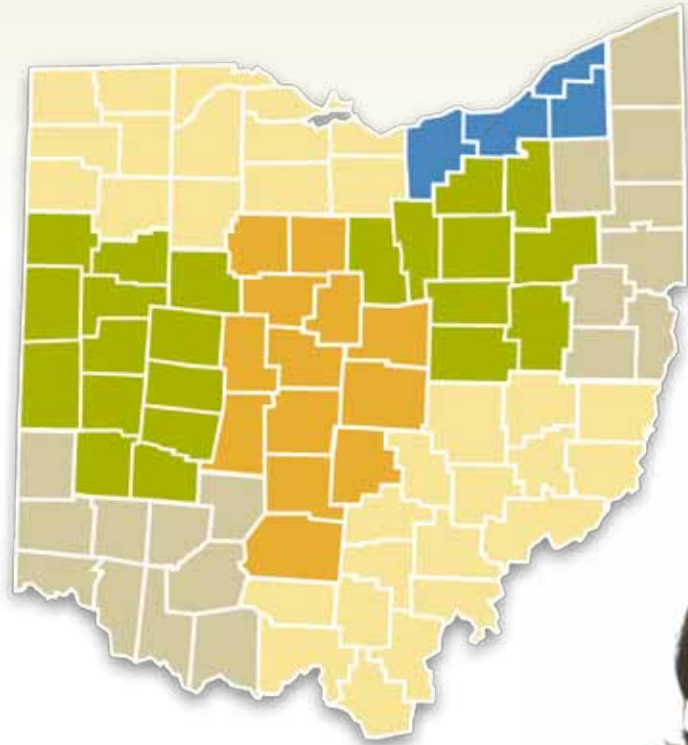

The Auditor of State's office has eight regional offices throughout Ohio.

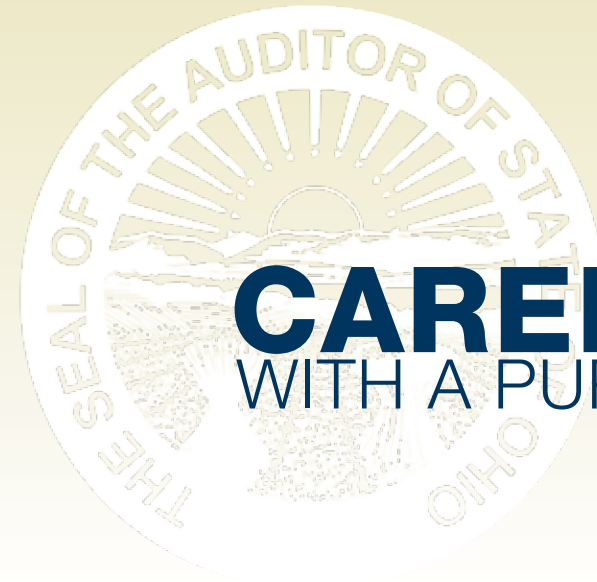

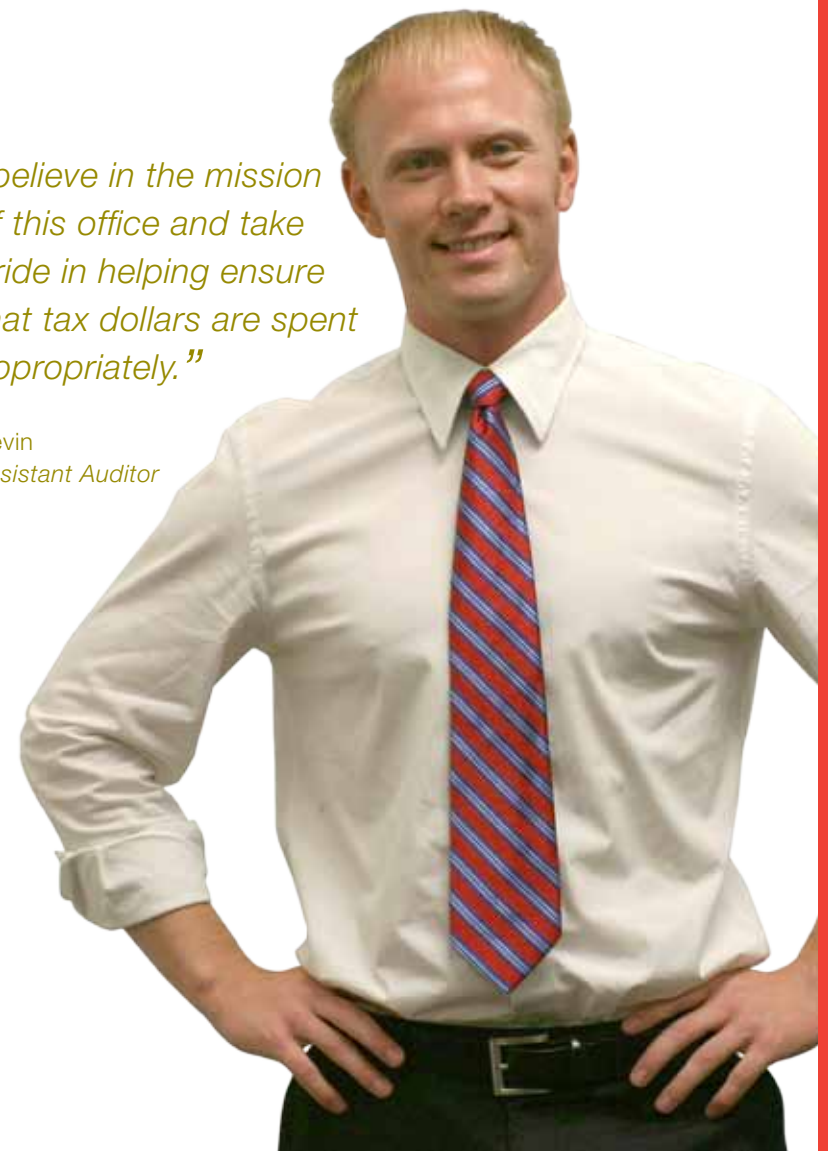
