**INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES**

To the Executive Committee:

We have performed the procedures enumerated below, which were agreed to by the Republican Party Executive Committee, Pike County, Ohio (the Committee), solely to assist the Committee in evaluating its compliance with Sections 3517.17 and 3517.18 of the Ohio Revised Code for the year ended December 31, 2004. Management is responsible for the Committee's compliance with those requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements. The sufficiency of the procedures is solely the responsibility of the Executive Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

**Cash Receipts**

We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed to amounts shown on the Ohio Campaign Finance Report.

We found no exceptions as a result of our procedures.

**Cash Reconciliation**

We compared the sum of the cash balances recorded on the Committee's Ohio Campaign Finance Report with cash balances reported on the bank statement from the Atomic Employees Credit Union as of December 31, 2004. We recomputed the mathematical accuracy of the reports.

We found no exceptions as a result of our procedures.

**Cash Disbursements**

There were no cash disbursements during the period January 1, 2004 through December 31, 2004.
