

#### INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Secretary of State of Ohio Democratic Executive Committee Lorain County 1985 North Ridge Road Lorain, Ohio 44055

We have performed the procedures enumerated below, to which the Lorain County Democratic Executive Committee (the Committee) agreed, solely to assist the Committee in evaluating its compliance with certain requirements included in Ohio Rev. Code Sections 3517.1012, 3517.13(X)(1), (2)(b), (3)(a), and (4), 3517.17, and 3517.18, for the year ended December 31, 2008. The Committee is responsible for complying with these requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements and applicable attestation engagement standards included in the Comptroller General of the United States' *Government Auditing Standards*. The sufficiency of the procedures is solely the responsibility of the Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

#### **Cash Receipts**

- 1. We inquired of the Committee whether they deposited all gifts from corporations, labor organizations and all gifts restricted to operations into the same fund into which they deposit amounts received from the State Tax Commissioner. Management informed us they received no such gifts.
- Our procedures required us to foot each Statement of Political Party Restricted Fund Deposits
  Ohio Rev. Code Section 3517.17 requires (Deposit Form 31-CC). The Committee did not file the
  required Deposit Form 31-CC. Rather, the Committee filed the Statement of Contributions
  Received (Form 31-A). We footed the Statement of Contributions Received filed for 2008. We
  noted no computational errors.

Ohio Rev. Code Section 3517.17(A) requires a political party to deposit into its restricted fund all public monies received from the Ohio Political Party Fund. Ohio Rev. Code Section 3517.1012(B) states, in part, that a county political party shall file deposit and disbursement statements, in the same manner as the party is required to file statements of contributions and expenditures under section 3517.10 of the Revised Code, regarding all deposits made into, and all disbursements made from, the party's restricted fund. Ohio Rev. Code Section 3517.10(C)(6)(b) states the Secretary of State shall prescribe the form for all statements required to be filed under this section. As prescribed by the Ohio Secretary of State, the Committee is required to use the Statement of Political Party Restricted Fund Deposits (Deposit Form 31-CC revised 3/05) to report all receipts from the Ohio Political Party Fund. This form should be used to file future annual reports.

### Cash Receipts (Continued)

- 3. We compared bank deposits reflected in 2008 restricted fund bank statements to total deposits recorded in Deposit Forms 31-A filed for 2008. The bank deposit amounts did not agree to the deposits recorded in the Forms. The Committee did not report \$63.70 received from the State Tax Commissioner in the January quarterly payment.
- 4. We confirmed amounts received from the State Tax Commissioner pursuant to Ohio Rev. Code 3517.17(A), and agreed all payments, with the exception of the January quarterly payment, to amounts shown on Deposit Forms 31-A filed for 2008. We also noted these receipts were not electronic funds transfer and therefore were not deposited timely in 2008. We recommend the Committee utilize EFT.
- 5. We scanned other recorded 2008 receipts for evidence that a corporation or labor organization may have exceeded the \$10,000 annual gift limit Ohio Rev. Code 3517.13(X)(3)(a) imposes. We found no evidence that any corporation or labor organization exceeded this limit.

#### **Cash Reconciliation**

- We recomputed the mathematical accuracy of the December 31, 2008 reconciliation for the bank account used for receipts and disbursements restricted pursuant to Ohio Rev. Code Section 3517.1012(A). Discrepancies were noted in which the 2007 Annual report carried over into 2008 requires an amended filing.
- 2. We attempted to agree the bank balance on the reconciliation to the bank statement balance as of December 31, 2008. The balances did not agree. The Committee had \$2,870 that was amended on the 2007 semiannual report. However, this amount should have been transferred from the restricted bank account. The ending book balance reported on the Campaign Finance report was (\$1,119.95) and the December 31, 2008 bank balance was \$1,497.30.
- 3. There were no reconciling items appearing on the bank reconciliation.

#### **Cash Disbursements**

1. Our procedures required us to foot each *Statement of Political Party Restricted Fund Disbursements* Ohio Rev. Code Section 3517.17 requires (Disbursement Form 31-M). The Committee did not file the required Disbursement Form 31-M. Rather, the Committee filed the *Statement of Expenditures* (Form 31-B). We footed each *Statement of Expenditures* filed for 2008. We noted one computational error (See Item 3 on Page 3 of this Report).

Ohio Rev. Code Section 3517.1012(B) states, in part, that a county political party shall file deposit and disbursement statements, in the same manner as the party is required to file statements of contributions and expenditures under section 3517.10 of the Revised Code, regarding all deposits made into, and all disbursements made from, the party's restricted fund. Ohio Rev. Code Section 3517.10(C)(6)(b) states the Secretary of State shall prescribe the form for all statements required to be filed under this section. As prescribed by the Ohio Secretary of State, the Committee is required to use the *Statement of Political Party Restricted Fund Disbursements* (Disbursement Form 31-M) to report all disbursements from the Ohio Political Party Fund. This form should be used to file future annual reports.

2. Per Ohio Rev. Code 3517.13(X)(1), we scanned Disbursement Forms 31-B filed for 2008 and inquired of management whether they transferred any cash from the restricted fund to any other political party account into which contributions may be made or from which contributions or expenditures may be made. We found no evidence of prohibited transfers.

- 3. We compared the amounts on checks or other disbursements reflected in 2008 restricted fund bank statements to disbursement amounts reported on Disbursement Forms 31-B filed for 2008. We found a computational error on the Statement of Expenditure Report of \$252.75 in which the bank disbursement exceeded the amount reported.
- 4. For each disbursement on Disbursement Forms 31-B filed for 2008, we traced the payee and amount to payee invoices and to the payee's name on canceled checks. The payees and amounts recorded on Disbursement Forms 31-B agreed to the payees and amounts on the canceled checks and invoices with the exception of checks made for rent and secretarial services in which no invoice/contract was provided to validate the expenditure.

We were unable to verify the endorsements on the checks because the imaged back of the canceled checks was not provided by the financial institution. We recommend the Committee make arrangements with their financial institution to provide the Committee with the front and back of all canceled checks.

- 5. We scanned the payee for each 2008 disbursement for evidence that it might represent a contribution or campaign-related disbursement, both of which Ohio Rev. Code 3517.13(X)(2)(b) prohibit. We found no evidence that any restricted fund disbursements represented contributions or campaign-related disbursements.
- 6. We compared the signature on 2008 checks to the list dated February 5, 2009 of authorized signatories the Committee provided to us. The signatory on all checks we selected was an approved signatory.
- 7. We scanned each 2008 restricted fund disbursement recorded on Disbursement Forms 31-B for evidence that it represented a transfer from the restricted fund to any other state or county political party, which Ohio Rev. Code 3517.13(X)(4) prohibits. We found no evidence of any transfers.
- 8. We compared the purpose of each disbursement listed on 2008 Disbursement Forms 31-B to the purpose listed on the vendor invoice and to the purposes Ohio Rev. Code Section 3517.18 permits. We found no instance where the purpose described on the invoice violated the restrictions of Ohio Rev. Code Section 3517.18.

We were not engaged to, and did not examine each *Statement of Contributions Received* and *Statement of Expenditures* filed for 2008, the objective of which would have been to opine on compliance. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that we would have reported to you.
