### INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Secretary of State of Ohio Democratic Executive Committee Union County 508 Rosehill Drive Marysville, Ohio 43040

We have performed the procedures enumerated below, to which the Democratic Executive Committee (the Committee) agreed, solely to assist the Committee in evaluating its compliance with certain requirements included in Ohio Rev. Code Sections 3517.1012, 3517.13(X)(1), 2(b), (3)(a), and (4), 3517.17, and 3517.18, for the year ended December 31, 2012. The Committee is responsible for complying with these requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements and applicable attestation engagement standards included in the Comptroller General of the United States' *Government Auditing Standards*. The sufficiency of the procedures is solely the responsibility of the Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

## **Cash Receipts**

- We inquired of the Committee whether they deposited all gifts from corporations, labor organizations and all gifts restricted to operations into the same fund into which they deposit amounts received from the State Tax Commissioner. Management informed us they received no such gifts.
- 2. We inquired of the Committee whether they were required to complete a *Statement of Political Party Restricted Fund Deposits* Ohio Rev. Code Section 3517.1012(B) requires (Deposit Form 31-CC). Management informed us there was no *Statement of Political Party Restricted Fund Deposits* due to the close out of the restricted account in 2009.
- 3. We inquired of the Committee whether they reopened a restricted fund bank account in 2012. Management informed us they closed the bank account in April 2009 and have not subsequently reopened a bank account for restricted funds as they have not received any restricted funds. We inspected the last bank statement available, April 2009, and it showed a balance of \$0 (zero).

## **Cash Disbursements**

1. We inquired of the Committee whether they were required to complete a *Statement of Political Party Restricted Fund Disbursements* Ohio Rev. Code Section 3517.1012(B) requires (Disbursement Form 31-M). Management informed us there was no *Statement of Political Party Restricted Fund Disbursements* due to the close out of the restricted account in 2009.

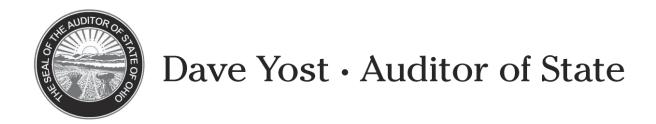
