#### INDEPENDENT ACCOUNTANT'S REPORT

We have examined Lucas Metropolitan Housing Authority, Lucas County, Ohio's management's assertion that the census data and pensionable wages reported to the Ohio Public Employees Retirement System as of December 31, 2014, and for the year then ended was accurate and complete.

Management asserts that:

- The census data provided to the Ohio Public Employees Retirement System as of December 31, 2014 is accurate and complete. Census data includes
  - o First and Last Name;
  - o Last four digits of the social security number;
  - o Contributions remitted to the plan;
  - Pensionable Compensation;
- The census data provided to the Ohio Public Employees Retirement System as of December 31, 2014 included all enrolled employees.
- Census data changes occurring during the year ended December 31, 2014 to an enrolled employee's eligible compensation were properly updated with the Ohio Public Employees Retirement System.
- All employees required to be enrolled in the Ohio Public Employees Retirement System were properly enrolled.
- The total pensionable wages and employee contributions information reported to the Ohio Public Employees Retirement System agrees with the payroll records of the employer.

Lucas Metropolitan Housing Authority's management is responsible for the assertions. Our responsibility is to opine on the assertions based on our examination.

Our examination followed attestation standards established by the American Institute of Certified Public Accountants and standards applicable to attestation engagements included in the Comptroller General of the United States' *Government Auditing Standards* and, accordingly, included examining, on a test basis, evidence supporting management's assertions and performing other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.
