We have examined the City of Mount Vernon's management's assertion that the census data and pensionable wages reported to the Ohio Public Employees Retirement System as of December 31, 2015, and for the year then ended was accurate and complete.

 - o First and Last Name;
 - Last four digits of the social security number;
 - o Contributions remitted to the plan;
