## DECLARATION OF FISCAL WATCH

Effective December 20, 2023, the Ohio Department of Education and Workforce declared the Mt. Healthy City School District, Hamilton County, to be in a state of fiscal caution in accordance with Section 3316.031 of the Ohio Revised Code. The declaration was based on an anticipated deficit for the fiscal year ending June 30, 2024, as well as the potential for deficits in future years.

Section 3316.031(C) of the Ohio Revised Code requires that the board of education of a district declared to be in fiscal caution provide a written proposal to the Ohio Department of Education and Workforce for correcting the budgetary conditions that prompted the declaration and for preventing the district from experiencing further fiscal difficulties. Upon a determination by the Ohio Department of Education and Workforce that the district has not provided an acceptable proposal and with the concurrence of the Auditor of State that this determination is reasonable, the district is to be declared in fiscal watch.

The Ohio Department of Education and Workforce has notified the Auditor of State that the Mt. Healthy City School District failed to submit an acceptable written proposal required by Section 3316.031(C), Revised Code, for correcting the conditions that prompted the declaration of fiscal caution. Additionally, they have requested that the School District be placed in fiscal watch in order to prevent further decline. Upon review of the Ohio Department of Education and Workforce's determination and based on the Mt. Healthy City School District's five-year forecast filed with the Ohio Department of Education and Workforce on November 29, 2023, which includes a deficit of \$5,062,643, \$20,549,721, and \$37,809,244 for the fiscal years ending June 30, 2024, 2025 and 2026, and based on the Mt. Healthy City School District Board of Education passing a resolution, dated February 12, 2024, stating their inability to adopt a financial recovery plan, the Auditor of State finds the Ohio Department of Education and Workforce's determination that the Mt. Healthy City School District be placed in fiscal watch to be reasonable.

Accordingly, the Auditor of State hereby declares the Mt. Healthy City School District to be in a state of fiscal watch under Section 3316.03(A)(3) of the Ohio Revised Code. A copy of this declaration is being submitted to Julie Turner, President of the Board of Education of the Mt. Healthy City School District, Kimberly Murnieks, State Director the Office of Budget and Management, Brigid Kelly, Hamilton County Auditor, and Stephen D. Dackin, Director. Ohio Department of Education and Workforce.
